

DOUBLE CIRCLE RANCH RIPARIAN FENCING PROJECT

EXECUTIVE SUMMARY

The Double Circle Ranch fencing project protects existing riparian habitats and improves water quality for both aquatic habitat and downstream municipal use, as well as highly valued recreational use.

This project coordinates with the ongoing USFS 13,000 Acre Sheep Wash Ecosystem Restoration Project, the ongoing Pigeon Burn, the proposed NO Bar Burn and Pinyon/Juniper Thinnings, and ongoing exclusion fencing in the Eagle Creek Corridor, funded through the Gila Watershed Partnership, in cooperation with the San Carlos tribe.

Our project consists of three phases.

Phase 1: Three and one-half miles of fence dividing Big Dry Pasture, creating a riparian pasture along Lower Sheep Wash, a sixth code watershed, thus allowing for effective grazing management and continued recovery of wetlands, benefiting three miles of Lower Sheep Wash.

Phase 2: One and one-half miles of fencing, along with one mile of natural barrier dividing NO Bar pasture and isolating 2.6 miles of Lower Smith Canyon, encouraging recovery of a 31 acre riparian corridor.

Phase 3: Reconstruction of 2.5 miles of USFS/San Carlos Reservation Boundary fence along a 3.8 mile stretch of Eagle Creek, a priority one stream, eliminating continued trespass cattle and the resulting damage to the Eagle Creek Riparian corridor.

The Double Circle Ranch is home and/or potential habitat for many sensitive or endangered species, including, but not limited to, Loach Minnow, Spikedace, Gila Chub, Sonora Sucker, Desert Sucker, Razorback Sucker, Speckled Dace, Lowland Leopard Frog, Narrow Headed Garter Snake, Arizona Toad, Longthin Dace, Roundtail Chub, Common Black Hawk, Yellow Billed Cuckoo, Northern Goshawk, and Mearn's Quail.

Protecting the watersheds on Double Circle Ranch benefits these species and other game and nongame species, such as antelope, elk, javalinas, mule deer, Mexican Gray Wolf, Mexican Spotted Owl, mountain lion and black bear.

The Double Circle Ranch Riparian Fencing Project will aid in preserving and improving water quality in the Upper Eagle Creek watershed.

PROJECT OVERVIEW

The Double Circle Ranch consists of 36,272 acres in the Apache/Sitgreaves National Forest, Clifton Ranger District, Greenlee County, Arizona. Historically, the Double Circle Ranch has been used for grazing of livestock for the past 150 years, resulting in substantial alteration of watershed vegetation, soil erosion, and hydrologic characteristics (Leopold, 1946).

The USFS has been working with permittees and private land owners to restrict livestock access to the Eagle Creek riparian corridor. The Double Circle allotment had exclusion fencing constructed along Eagle Creek in 1994. An additional 100 acres of Eagle Creek corridor and riparian habitat were fenced off in 1999.

The Double Circle Ranch is in the fourth code basin of the Gila River Watershed and comprises seventeen percent of the Eagle Creek Fifth Code Watershed and six percent of the Lower Blue Fifth Code Watershed, both priority one streams/rivers (USFWS 2002 B.O.).

A five-mile stretch of Eagle Creek, which is an eighty-three mile tributary of the Gila River, forms the western border of the ranch. Three miles of Eagle Creek on the Double Circle allotment is designated critical habitat for both Loach Minnow and Spikedace. Spikedace have been documented near the confluence of Sheep Wash and Eagle Creek. Eagle Creek retains more native fish species than any other stream in the Gila River basin (USFWS 2002 B.O.).

Approximately three percent (996 acres) of the ranch consists of riparian vegetation, which is improving in both the Eagle Creek and Sheep Wash watersheds (USFWS 2002 B.O. and USFS 1998 B).

The goal of the DOUBLE CIRCLE RANCH RIPARIAN FENCIN PROJECT is to continue ongoing improvements in the Eagle Creek and Sheep Wash watersheds, benefiting both endangered species and game and nongame species indigenous to the area, improving water quality for downstream municipal sources, and enhancing recreational opportunities in the Eagle Creek area. To achieve this goal, the project will consist of three distinct phases.

PHASE 1 3.5 Mile Big Dry Fence

Objectives

- 1. To help implement habitat protection ongoing with the USFS in the LOWER SHEEP WASH ECOSYSTEM RESTORATION PROJECT in partnership with AZGF, NWFF, Greenlee County, Arizona Mule Deer, and others.
- 2. To isolate and allow effective management of 114 acres of riparian habitat along 3 miles of intermittent and interrupted lower Sheep Wash.
- 3. To exclude livestock grazing from Sheep Wash during critical Chiracahua Leopard Frog breeding season from March through September (see map no. 2).
- To allow summer grazing in the north half of Big Dry pasture to allow for proper rest and rotation for improved forage providing enhanced habitat for wildlife corridors across the uplands.

Problems

1. Sheep Wash and Sheep Spring need protection from livestock effects during the March through September breeding season of the Chiracahua Leopard Frog.

- 2. The Big Dry pasture is one of the Ranch's largest pastures at 4,423 acres. Currently, we may not graze the entire pasture from March through September due to frog habitat. Consequently, the pasture may not be available when needed for rest and deferment of other pastures.
- 3. A fence is necessary to help implement habitat protection ongoing with the USFS in their Lower Sheep Wash ecosystem restoration project.

Solutions

- 1. The proposed 3.5 mile fence line will divide Big Dry Pasture, providing protection of critical frog habitat during their breeding season, as well as the entire Sheep Wash riparian area during critical growing periods.
- 2. The project will create an upland pasture for use during the spring and summer growing seasons, allowing for rest and rotation for improved forage.

Anticipated Years of Project-Related Benefit

The fence built to USFS specification is expected to last a minimum of 25 years with periodic maintenance.

PHASE 2 2.5 Mile NO Bar Fence

Objectives

- 1. To help implement habitat restoration and improvements proposed by the USFS with the NO Bar prescribed burns in 2006 and 2007.
- 2. To isolate and allow effective management of 2.6 miles of lower Smith Canyon riparian habitat to encourage riparian recovery of 31 acre corridor, complementing Lower Sheep Wash Ecosystem Restoration Project.
- 3. To allow rotational grazing in order to provide rest and deferment for improved forages and wildlife habitat.
- 4. To exclude livestock from burn areas for two full growing seasons to allow reseeding and recovery of burn areas.

Problems

- Currently, the NO Bar pasture has an over abundance of Pinyon/Juniper growth, frequently having two times the canopy cover expected on its soil type. This provides a high risk of catastrophic fire, threatening water quality and quantity and T & E species, including Spikedace and Loach Minnow.
- 2. It is difficult to effectively manage the Smith Canyon riparian area without the ability to isolate upland and riparian habitats of the NO Bar pasture.
- 3. Currently, there is no way to isolate prescribed burn areas from grazing while the area recovers for two full growing seasons.

Solutions

- 1. Construction of 1.5 miles of fence line in conjunction with 1.1 miles of natural barrier will divide the NO Bar pasture, allowing proper management of Smith Canyon riparian area.
- 2. The division will facilitate rotational grazing, allowing for rest and deferment for improved forages.
- 3. Livestock can be effectively excluded from prescribed burn areas for two full growing seasons.

Anticipated Years of Project-Related Benefit

The fence built to USFS specification is expected to last a minimum of 25 years with periodic maintenance.

PHASE 3 2.5 Mile San Carlos Reservation/USFS Boundary Fence

Objectives

- 1. To extend riparian fencing reconstruction currently ongoing with the Point of Pines Project, a joint effort between USFS, San Carlos Tribe, ADEQ, USFWS, and the Gila Watershed Partnership.
- 2. To improve water quality in Eagle Creek, a priority one stream, by excluding livestock from the riparian corridor.
- 3. To protect T & E species (see map no. 2), as well as game and nongame habitat.

Problems

- 1. Extensive flooding and run off from the January 2005 storms washed out and/or severely damaged 2.5 miles of riparian fencing along Eagle Creek to the extent that it cannot be repaired.
- 2. Damaged fencing allows trespass cattle into critical and sensitive habitat areas threatening T & E species.
- 3. The Point of Pine Project funds reconstruction of one-half mile of riparian fence at the crossing onto the reservation. The actual amount of riparian fence damaged extends 1.5 miles each way from the crossing.

Solution

Reconstruction of 2.5 miles of riparian fence will exclude livestock from Eagle Creek, protecting water quality and aquatic and riparian habitat, thus protecting T & E species.

Matching funds in the amount of \$51,600 for Phase 1 and 2 of this project have been applied for from the LCCGP Grant.

Phase 1 of our project dovetails with the USFS Sheep Wash Ecosystem Restoration-Lower Sheep Wash Block, which specifically deals with the protection and restoration of critical riparian areas on our ranch. There are many contributing partners to the ongoing project, such as the Safari Club, the National Wild Turkey Federation, the Arizona Elk Society, and the Mule Deer Foundation, to name a few (see the Sheep Wash Ecosystem Restoration paper). Matching funds in the amount of \$58,300 have been obtained, with \$34,000 more proposed.

Phase 2 of our project will coincide with the planned continuation of thinning and prescribed burns by the USFS on and around our allotment. The ongoing Pigeon burn and the planned NO Bar/Four Bar prescribed burns will require that we utilize our pastures while allowing treated areas adequate rest. There are many partners in the project, both now and in the future. Some of these partners are ADEQ, AZGF, AWPF, Eastern Arizona Counties Resource Committee (RAC), Gila Watershed Partnership, NFWF, NRCS, Southeastern Arizona Sportsmen Club, and various groups (see the Pigeon Ecosystem Restoration Project information paper). Funds in the amount of \$256,000 have been obtained for this project. Double Circle Ranch has contributed \$2,300 for stabilizing and hardening of driveway across Smith Canyon.

As used throughout this Contract, including the General Provisions, Special Provisions, and the Scope of Work, the following terms shall have the meaning set forth below:

- a. "Administrative Cost" means those costs that are traditionally termed indirect and overhead.
- b. "Agreement" or "Contract" means this Arizona Water Protection Fund Grant Award Contract between the Commission and Grantee.
- c. "Arizona Water Protection Fund" means the fund established by A.R.S. § 45-2111 and consisting of monies as set forth in A.R.S. § 45-2112.
- d. "Chair" means the chairperson of the Arizona Water Protection Fund Commission or a person duly authorized by the Chair to act on the Chair's behalf.
- e. "Commission" means the Arizona Water Protection Fund Commission or its authorized representative.
- f. "Deliverables" means the reports, documentation, and other materials developed for submission to the Project Manager by the Grantee in the course of the Grantee's performance under this Contract.
- g. "Equipment" means one or more tools, implements, computers, computer hardware, computer software, cameras, camera accessories, vehicles, or instruments purchased with Grant funds pursuant to either this Contract or a prior Contract between the Commission and the Grantee that is intended to be used to carry out the purposes of this Contract.
- h. "Grantee" means the person, firm, or organization performing the work or delivering the items described in this Contract.
- i. "Grant Application" means the application filed by the Grantee upon which this Contract was awarded.
- j. "Grant Award Contract" means this Contract between the Grantee and the Commission.
- k. "Operation and Maintenance Period" means the period of time during which grant-assisted structures, human access or educational facilities, revegetation sites, and any other grant-assisted improvements shall be operated and maintained.
- 1. "Project" means the total of all work to be performed by the Grantee as set forth in this Contract.
- m. "Project Manager" means the Arizona Department of Water Resources technical Staff person delegated by the Chair to administer this Contract.

- n. "Scope of Work" means that part of this Contract that describes the work to be performed by the Grantee to accomplish the Project purpose. If the Scope of Work conflicts with the General or Special Provisions, the terms of the Scope of Work shall govern.
- o. "Shall" means what is mandatory.
- p. "Special Provisions" means those provisions of this Contract that alter or augment the General Provisions. If the Special Provisions conflict with the General Provisions, the Special Provisions shall govern.
- q. "Staff" means the technical, legal, and administrative staff, including the Project Manager, provided to the Commission by the Director of the Arizona Department of Water Resources pursuant to A.R.S. § 45-2114.
- r. "State" means the State of Arizona, including the Department of Water Resources.
- s. "Task" means the specific provisions in the Scope of Work of this Contract that describe the nature and manner of the specific work to be performed and the Deliverables to be submitted to the Project Manager by the Grantee.

2. GENERAL REQUIREMENTS:

- a. This Contract shall be interpreted in accordance with Arizona law.
- b. The Grantee shall obtain and maintain all licenses, permits, and authorizations necessary to perform its obligations under this Contract. The Grantee is responsible for compliance with all applicable local, state, and federal laws.
- c. In this Contract, Special Provisions alter the General Provisions. If the Special Provisions conflict with the General Provisions, the Special Provisions shall govern. If the Scope of Work conflicts with either the Special or General Provisions, the Scope of Work shall govern.

3. RELATIONSHIP OF THE PARTIES:

The parties agree that the Grantee shall not be considered an employee, associate, partner, officer, joint venturer, or agent of the Commission or the State as a result of this Contract. The Grantee is solely responsible for the planning, design, scope, and implementation of the Project funded through this Contract. Neither the Commission nor the State is responsible for any liabilities resulting from the Grantee's planning, design, scope and implementation or performance of the Project funded through this Contact.

4. BOOKS AND RECORDS:

The Grantee shall keep adequate books, accounts, files, and records related to work performed and expenditures incurred for a period of five (5) years after the termination of this Contract. Such books, accounts, files, and records shall be made available for inspection by the

Commission, Staff, or other appropriate agents of the State upon timely written notice. Financial records shall: (1) identify the Tasks completed; (2) include records of the time the Grantee spent performing the Tasks; and (3) include original copies of invoices, statements, sales tickets, billings for work, and similar documents as necessary to document all expenditures applicable to this Contract.

5. INSPECTION AND AUDIT:

Commission representatives and other appropriate agents of the State shall, during the term of this Contract, be entitled to review and inspect the Grantee's Project site and data which pertain to the work specified in the Scope of Work. Timely written notice shall be provided prior to any inspection. The right to inspect shall include review of operation and maintenance of the Project site and performance of field analyses and data collection to assess the degree of success of the Project.

All data collected and maintained pursuant to the requirements of this Contract shall be subject to examination on the request of the Auditor General in accordance with A.R.S. § 41-1279.

6. INDEMNIFICATION:

The parties to this Contract agree that the Grantee shall indemnify, defend, and hold harmless the Commission and the State, including the Department of Water Resources, for all claims which result in vicarious/derivative liability of the State as a result of the act, omission, misconduct, or other fault of the Grantee, its agents, officials or employees.

7. **RESOLUTION OF DIFFERENCES:**

- a. Disputes arising during the performance of this Contract will be resolved to the maximum extent possible through cooperation and coordination of the Grantee and Staff. If the Grantee and Staff are unable to resolve the differences or circumstances require an immediate decision, the Project Manager will refer the conflict to the Commission for resolution.
- b. Disputes arising out of this Contract are subject to arbitration to the extent required by A.R.S. § 12-133 and § 12-1518.
- c. Disputes arising out of this Contract are subject to the jurisdiction of the Superior Court of the State of Arizona.

8. STOP WORK NOTICE:

In the event of unapproved changes in the Scope of Work, performance or changes outside the scope of the Contract, illegal or unpermitted activities, or other material discrepancies between the Contract and the Grantee's activities, the Commission reserves the right to issue notice to the Grantee to stop work. The notice will further specify that the Commission will not approve

resumption of performance or further payments until the issue or issues identified in the stop work notice have been resolved to the satisfaction of the Commission.

9. TERMINATION OF CONTRACT:

a. The Commission, in addition to other rights set forth elsewhere in this Contract, reserves the right to terminate this Contract in whole or in part, without cause, effective thirty (30) calendar days after receipt of written notice of termination sent by certified mail to the Grantee.

The Commission, in addition to other rights set forth elsewhere in this Contract, reserves the right to terminate this Contract in whole or in part, for cause, effective upon receipt of written notice of termination sent by certified mail to the Grantee.

In the event of termination as provided in Paragraph 9 (a):

- 1) The Grantee shall stop work as specified in the notice of termination.

- c. In the event of cancellation under Paragraph 9 (b) of this Contract, or if the term of the Contract expires, the Grantee shall receive payment as established in Paragraph 9 (a) (2) and (3) of this Contract.
- d. In the event that the parties mutually agree to terminate a portion of the Contract, the Grantee shall continue to perform work under this Contract to the extent not terminated under the provisions of this Paragraph.
