NEED STATEMENT – PROBLEM ANALYSIS: GMU 4B is lacking reliable, year-round sources of water for wildlife. Wildlife depend on manmade wildlife waters such as catchments, well developments and dirt stock tanks. In years with below average precipitation both catchments and dirt tanks are prone to going to dry. This well development will provide a reliable source of water regardless of precipitation.


