Brief Project Summary : Purchase 2000 gallons of fuel for the High Point and Ellsworth wells. High Point well feeds over 30 miles of buried pipeline with 26 drinker locations. These drinkers are disbursed in a manner that about 50 sections of wildlife habitat are served from this well. Ellsworth well feeds 11 miles of buried pipeline with 9 drinkers. These drinkers are disbursed in a matter that about 20 sections of wildlife habitat are served from this well. We expect fuel to cost up to \$8,000.00. The remaining \$4,000.00 will be used to address any potential maintenance issues that arise with the wells during 2017.

NEED STATEMENT – PROBLEM ANALYSIS:

Perennial water on the north part of Unit 4A is limited to man-made structures. Stock ponds, wildlife catchments, and wells provide the majority of water to wildlife and cattle during dry periods. In the 1990 a HPC project was undertaken to create a water system to provide perennial water on the Ohaco Ranch. This was the Hi Point Well Project. Ellsworth Well has been in operation for over 30 year and provides wildlife an excellent source of water. Between the two water systems they provide water to over 70 sections pinyon-juniper and grassland habitat perennial water. It is important to wildlife and livestock to maintain and continue providing perennial on this system.

PROJECT OBJECTIVES:

Continue to partner with the Ohaco Ranch to provide a total of 2000 gallons of fuel for both High Point Well and Ellsworth Well. Provide funding for any maintenance that might be required on the wells.

Hi Point and Ellsworth- Unit 4A just along the northwest portion of Forest Service land and the Private Ranch just North of the Forest Service Boundary. These two well serves 39 drinkers and approximately 41 miles of pipeline. Water is located on both Forest Service and private land. The total wildlife habitat affected by this system is over 70 sq/miles.


