PREFACE

This Interagency Agreement is made by and between the Bureau of Reclamation, represented by the Arizona Projects Office of the Lower Colorado Region, hereinafter referred to as "Reclamation," and the Forest Service, represented by the Tonto National Forest of the Southwestern Region, hereinafter referred to as the "Service," pursuant to the Project Supplemental Agreement (PSA) for Theodore Roosevelt Dam dated September 23, 1988, and required by the Amendment to the Fish and Wildlife Coordination Act (FWCA) Report (dated May 4, 1989) on Plan 6, Regulatory Storage Division, Central Arizona Project, Arizona.

PURPOSE

In consultation under FWCA, the Service, Arizona Game and Fish Department (AGFD), Reclamation, and the Fish and Wildlife Service (FWS) agreed that upland desert and riparian habitat losses from Plan 6 construction could, in part, be mitigated through the promotion of better distribution of livestock grazing by implementation of new and revised Allotment Management Plans (AMP). Eleven allotments (see Table 1, below, List of Allotments) will be examined for opportunities to utilize fencing and water developments to meet vegetative response objectives, and achieve the desired livestock distribution throughout the allotments, especially below the Inflow Design Flood (IDF). It is the intent of this agreement to promote cooperative management within the Project Area as provided in Article VI.-G of the PSA, consolidate the individual AMP revisions into one centralized area for more efficient monitoring, and provide a vehicle for the expenditure of funding for mitigation which the interagency team has approved.

STIPULATIONS

Reclamation will provide funds in an amount not to exceed \$647,360 (which includes \$465,000 for construction of features described in the AMPs, \$15,000 for riparian habitat protection in Salome Creek, \$48,000 for survey and design, \$50,000 for monitoring, and \$69,360 for Service administrative costs) for actual costs incurred by the Service to accomplish the mitigation team recommendations. Total estimated costs are shown on Table 2 below by Fiscal Years. (On Table 2, costs for Salome riparian habitat are included with the range improvement costs.)

Reclamation will participate with the Service in the development of each Grazing Strategy and associated improvements. For each AMP, the Service will provide for Reclamation review the following documents:

1. Completed AMP; signed by the approving official(s).
2. Environmental Assessment, signed by the approving official(s), including any appropriate clearances from cooperating agencies.
3. Map, associated list, and projected costs of all features (e.g., fencing, water developments, etc.) which will be constructed with Reclamation funding only under this agreement. These items will be discussed between appropriate Service and Reclamation representatives prior to the approving Service official signing the AMP.

After Reclamation review and acceptance of the above documents, the agreement will be modified to add each AMP as an exhibit (labeled as Exhibits A-J as listed in Table 1), and to obligate funds for that work.

The performance of any obligation or the expenditure of any funds by the Government under this agreement is contingent upon obtaining the necessary

appropriations, and the funds being allocated and made available for the work required hereunder.

Quarterly billing requests will be sent (with backup information on types of costs incurred and appropriate vouchers from subcontractors for labor and materials) to the Project Manager, Attention: Code 804, Arizona Projects Office, P.O. Box 9980, Phoenix, Arizona 85068. All billings will also specify Reclamation's agreement number, 2-AA-32-00150; designate the allotment(s) in which the funds were spent; and indicate whether costs were for monitoring or for any other activities related to improvements.

This agreement shall be in effect from the date of signature by both parties until December 31, 2001, unless terminated sooner by mutual agreement.

This agreement may be modified, supplemented, extended or superseded at any time by sub-agreements thereto and/or by written concurrence between Reclamation and the Service.

Reclamation and the Service agree to meet and confer as necessary to resolve interagency differences with respect to the implementation of this agreement.

IN WITNESS WHEREOF, the parties hereto have agreed to this Interagency Agreement for the revision of grazing Allotment Management Plans to improve range conditions and wildlife habitat at Roosevelt Lake, to be effective upon the last date of signature of this agreement.
