11. DESCRIPTION OF MODIFICATION:

This modification incorporates Attachment B, Allotment Management Plan for the Dutchwoman Allotment into the agreement; adds fiscal year 1993 funding in the amount of \$48,720 for the Plan; adds fiscal year 1993 funding in the amount of \$28,705 for the Bar V Bar/Campaign Allotment, which was incorporated into the agreement under Modification No. 001; and specifies the estimated cost in the amount of \$148,400 for construction and monitoring of the Dutchman Allotment. Total funding for this agreement is hereby increased from \$30,800 to \$108,225.

Except as provided herein, all terms and conditions of the document referenced in Block 9, as heretofore changed, remain unchanged and in full force and effect.
