Brief Project Summary: Approximately 100 acres of invasive juniper trees will be pushed with a bull dozier. Due to the cooperation of the permittee and the use of their heavy equipment we are able to keep the cost at \$100.00 per acre. This project will restore historic grasslands in prime elk and deer habitat. This project will also dovetail nicely with several water tank repair and new construction projects that are also being proposed on Hardscrabble Mesa this year.

NEED STATEMENT – PROBLEM ANALYSIS:

Hardscrabble Mesa is in the middle of the most densely populated elk area in unit 22. During fall surveys the AGFD routinely counts between 300-400 elk on the mesa alone. The Hardscrabble Mesa Allotment has recently been acquired by a new permittee who has been working hard to recover the habitat and water resources that had been neglected for several years. This project along with two extensive water projects being proposed will go a long way towards providing adequate forage and water for elk, deer and many other game and non-game species for years to come.

PROJECT OBJECTIVES:

The objective if this project is to remove invasive juniper trees on approximately 100 acres of historic grasslands.

The permittee will use their own heavy equipment and dozer operators to complete the project. The project boundaries have already been marked and approved by the US Forest Service.
