NEED STATEMENT – PROBLEM ANALYSIS:

Hardscrabble Mesa is in the middle of the most densely populated elk area in unit 22. During fall surveys the AGFD routinely counts between 300-400 elk on the mesa alone. The Hardscrabble Mesa Allotment has recently been acquired by a new permittee who has been working hard to recover the habitat and water resources that had been neglected for several years. This project along with another water project and a juniper push being proposed will go a long way towards providing adequate forage and water for elk, deer and many other game and non-game species for years to come.

PROJECT OBJECTIVES:

Improve water availability for elk and deer
Ensure water availability year round

PROJECT DESCRIPTION AND STRATEGIES:

Use heavy equipment to clean and repair 8 dirt tanks
Seal two tanks with bentonite.
The permittee will provide the heavy equipment and most of the labor.
