**NEED STATEMENT – PROBLEM ANALYSIS:**

The Pole Hollow Allotment West of Payson is an area of good grass and forage for wildlife, but water is a limiting factor. The Pole Hollow Allotment has been neglected for many years and is being proposed as a contract project. Due to the fact that this will be a strictly contracted project there are very little matching funds. Partial funding would also be acceptable to try to get some water to the area.

Improve water availability for elk and deer  
Ensure water availability year round

Remove sediment from existing dirt tanks  
Repair and damage to existing berms  
Seal two tanks with bentonite.
