	After the Bear fire, there was significant damage to approximately 8 miles of fence which will require a complete re-build. 6 miles of that fence received enough damage to weaken the fence supports and ruin the wire. 1 mile was completely destroyed by fire. There is an estimated 5 miles that will need general post fire repair from burned posts and stays. Around 12 miles of fence are still in good repair since they did not receive fire impacts. The work needs to be completed to keep the permittees in compliance with their federal grazing permits, to keep their livestock in the designated allotment, and to keep all livestock safe and

After the Cow fire, there was significant damage to approximately 21 miles of fence which will require repair or rebuild. 11 miles of that fence received enough damage to weaken the fence supports and ruin the wire. 10 miles will need to be completely reconstructed. The remaining approximately 29 miles of fence has minimal damage.
