

## Arizona Post-Wildfire Infrastructure Assistance Program Grant Summary

Coconino County Sheriff's Office	The Coconino County Sheriff's Office owns a radio tower building on O'Leary Peak in Flagstaff, AZ that is leased from the US Forest Service. This building houses radio equipment, radio repeaters and solar batteries for the radio communications infrastructure owned and utilized by the Sheriff's Office, Summit Fire Department, and US Forest Service, National Parks Service (Wupatki, Sunset Crater national monuments), and other law enforcement agencies as needed. On June 17, 2022, the Pipeline Fire burned through O'Leary Peak causing fire damage to the building. The building integrity has been compromised and will need to be replaced. A contractor on state contract will replace the building and solar panels with new 20 year warranty Enviro building. They will replace solar panels and wiring, and remove undamaged radio equipment and batteries from old building and safely store. They will remove the old building and solar panels. They will build the new building, mount the new solar panels and install new wiring. They will reinstall the radio equipment and batteries. They will test all equipment and electronics to make sure all is working properly.	\$ 41,600.00
Arizona Association of Conservation Districts	The Scarborough Allotment is over 7,000 acres of Forest Service and private land of which 3,671 acres was burned. Over 7 miles of fence were destroyed by the griffin/copper canyon fire. All infrastructure needs repair and/or replacement.	\$ 295,820.00
Arizona Association of Conservation Districts	The Devils Canyon Allotment/JI Ranch is 18,685 acres of Forest Service Land of which 7,805 acres were burned. There is 6,960 acres of Arizona State Land of which 6,960 acres were burned. Over 56% of this ranch was burned. 11,890 feet of pipelines and over 9 miles of fence were destroyed by the telegraph fire. All infrastructure needs repair and/or replacement.	\$ 490,290.00
Arizona Association of Conservation Districts	The Diamond/Cross F Allotment is 58,143 acres of Forest Service land of which 17,840 acres was burned. 30% of this ranch was burned. The Bush Fire destroyed over 15 miles of fence requiring removal and replacement, and over 7 miles of hazardous fence removal. All infrastructure needs repair, removal and/or replacement.	\$ 499,830.00
Arizona Association of Conservation Districts	Horse Creek Farms is over 155,000 acres of Forest Service Land of which 90,000 acres was burned. 55 % of the ranch was burned. Two corrals, two pipelines and over 8 miles of fence were destroyed by the bush fire. All infrastructure needs repair and/or replacement.	\$ 500,000.00
Arizona Association of Conservation Districts	The Strawdinger Project is over 39 acres of private land. Corrals, pipelines, and solar were destroyed by the telegraph fire. All infrastructure needs repair and/or replacement.	\$ 24,200.00
Pheasants Forever	The Elgin Bridge Fire burned 2,149 acres in the Sonoita Valley, including roughly 1,500 acres on the Rose Tree Ranch across privately deeded, ASLD, and BLM leased lands. Infrastructure damage includes 4 miles of fence line that will need to be replaced with a 2-mile portion of 5-strand barbed wire fence and a 2-mile portion of 4-strand barbed wire fence. Additionally, 1-mile of pipe that distributed water from storage tanks was burned, rendering the line useless. Pipes to be replaced are located on ASLD lands and the fence lines border Private, ASLD, and BLM lands.	\$ 32,000.00
