Please see the information below in regards to your request and additional questions.

This email serves as completion and closure of your request.

The APWIAP grant listed on line #1 was intended for the BLM's Ponderosa and El Capitan grazing allotments, which burned in the 2021 Telegraph Fire. According to the BLM, these allotments have different grazing permittees. Please provide the amounts that were dedicated to each of these allotments from this \$361,500 grant.

The Ponderosa_El Capitan is a BLM lease, State Land Lease and private land. This project should not get mixed up with the name El Capitan with the Forest Service Allotment named Capitan. The Forest Service changed the name of that allotment. There is only 1 permit holder for the Ponderosa_El Capitan project and will receive the entire amount of \$361,500.00.

On line #4 of the attached file, it explains this \$324,000 grant went to grazing allotments burned by the 2020 Bighorn Fire, which occurred in the Coronado National Forest's Santa Catalina Ranger District. There were two grazing permittees affected by this fire. One was the permittee for the Samaniego, Canada del Oro, American Flag, Interocean & Finley Springs grazing allotments. The other was the permittee for the Bellota grazing allotment. Please provide the specific amounts that were dedicated to these allotments.

Carlink Ranches is the only project for the Bighorn Fire. This contract is for Forest Service (Bellota Allotment) and private land. They are receiving the entire \$324,000.00.

The last four rows listed in the attached file were for grants, totaling \$1,097,600, for Tonto National Forest grazing allotments affected by the Telegraph Fire. Please provide the names of each of the grazing allotments each of these grants were intended for.

Tonto National Forest is contributing 50% of the funding required to complete the boundary fence project. Because they were unable to secure funding for the entire 74.2 miles, AACD has submitted 4 projects to the DFFM Fire Recovery Fund. No individual is applying for boundary fence as no individual is the direct beneficiary of this recovery effort. Boundary fence recovery efforts support the projects involving interior fence projects already underway.

Beneficiaries of these projects are private landowners, BLM permit holders, county land managers, Arizona State Land Department and Federal Land managers.
