Dear Gene:

This letter will serve as Amendment Number One to your original January 20, 2004 Annual Operating Instructions (AOI) for the Apache Maid Allotment. This Amendment is the result of drought conditions within the winter range of your allotment. Insufficient precipitation has resulted in poor forage growing conditions and livestock water availability has necessitated a change in the range allotment's initial grazing schedule. The AOI remains the same, with the exception of the grazing pasture rotation schedules and stocking levels as described below.

Your grazing application for the 2004 grazing season was approved for 411 cattle (cow/calf/bull), with 634 cattle (cow/calf/bull) in Non-Use (Resource Protection – Drought Management) status. However, on April 17, 2004 you reduced your herd from 411 to 370 head due to the drought rangeland conditions. The District and Forest commends you for your voluntary reductions in permitted livestock numbers, keeping stocking numbers according to current drought conditions.

Your 2004 grazing seasons permitted livestock numbers for the Apache Maid Allotment from March 1, 2004 to February 28, 2005 have changed as follows:
