This document serves as your 2024 Amended #1 Annual Operating Instructions (AOI) for the Apache Maid Allotment. This amendment only affects section II Grazing Schedule, of the 2024 AOI, to determine the dates and numbers for the move to summer range.

**I. GRAZING SCHEDULE**

**Changes to the grazing schedule will be made only with prior Forest Service approval.**
