**NEED STATEMENT – PROBLEM ANALYSIS:**

The South side of the Christopher Mountain is an area of diverse wildlife habitat but little perennial water. This project will space perennial water sources throughout the area to provide for an abundance of wildlife species. This project is also in the area of a 5000 acre burn plan that was proposed this year. The combination of burning plus water development construction will dramatically improve the wildlife habitat in the area.

**PROJECT OBJECTIVES:**

Provide wildlife water for both game and non-game species throughout the entire South side of Christopher Mountain.

**PROJECT DESCRIPTION AND STRATEGIES:**

This proposal is to provide money to rent a bull dozer and provide the needed diesel fuel to build 4 new dirt tanks in the Christopher Mountain area. The owner of the Ellenwood Ranch will facilitate the rental of the dozer, the purchasing of the fuel and also provide the labor. The Ellenwood Ranch will also facilitate the purchasing of materials and construction of 2 new trick tanks.
