MODIFICATION NO. 1

to

COOPERATIVE STEWARDSHIP AGREEMENT FOR RECREATIONAL ACCESS

Between

THE ARIZONA GAME AND FISH COMMISSION

and

FLYING M RANCH, LLLP Kathryn Metzger

The purpose of this Modification is to extend the Cooperative Stewardship Agreement for Recreational Access by five (5) years and provide the Landowner an additional one hundred thousand dollars (\$100,000.00) with Flying M Ranch LLLP through March 20, 2031.

WHEREAS, The Arizona Game and Fish Department ("Department"), under the authority of the Arizona Game and Fish Commission, and the Flying M Ranch LLLP, represented by Kathryn Metzger ("Landowner"), entered into a Cooperative Stewardship Agreement for Recreational Access ("Agreement"), dated March 21, 2016, for the purpose of providing public recreational access through, upon, or across lands owned or legally controlled by the Landowner.

WHEREAS, The Department and the Landowner desire to continue to share in this mutually beneficial stewardship agreement;

THEREFORE, The Parties agree to modify A.1, B.8, III.A, III.D, and III.Q. to extend the recreational access by five (5) years;

The Agreement is hereby modified as follows:

A. The Arizona Game and Fish Department Shall:

1. Provide additional funding to the Landowner in the amount of one hundred thousand dollars (\$100,000.00) for public recreational access on the Subject Property. This additional funding will bring the total amount of the Agreement to three hundred and fifty thousand dollars (\$350,000.00). Payment shall be made in one installment of one hundred thousand dollars (\$100,000.00) which will be provided within 30 days of receipt of invoice from the Landowner.

B. The Landowner Shall:

8. Notify the Department in writing of a pending sale or transfer of the Property or any portion thereof at least 60 days prior to the date of transfer or close of escrow. In the event such sale or transfer of the Property results in termination of public recreational use and/or access across the Property, the Landowner shall reimburse the Department on a prorated basis for the remaining term of this Agreement.

III. Miscellaneous Terms and Conditions:

- A. The term of this agreement shall extend the original agreement for an additional 5 years and remain in effect until March 19, 2031.
