MODIFICATION NO. 1 to COOPERATIVE STEWARDSHIP AGREEMENT FOR RECREATIONAL ACCESS Between THE ARIZONA GAME AND FISH COMMISSION and GRIFFIN CATTLE RANCH, LLC

The purpose of this Modification is to extend the Cooperative Stewardship Agreement for Recreational Access for ten (10) years and provide the Griffin Cattle Ranch, LLC an additional forty-five thousand dollars (\$45,000.00) for access through May 24, 2033.

WHEREAS, The Arizona Game and Fish Department ("Department"), under the authority of the Arizona Game and Fish Commission, and Griffin Cattle Ranch, LLC as represented by Therese Hicks ("Cooperator"), entered into a Cooperative Stewardship Agreement for Recreational Access ("Agreement"), dated May 24, 2018, for the purpose of providing public recreational access through, upon, or across lands owned or legally controlled by the Cooperator;

WHEREAS, The Department and the Cooperator desire to continue to share in this mutually beneficial stewardship agreement.

THEREFORE, The Parties agree to modify A.1, B.1, C.3a and C.4 to extend public recreational access through or across Subject Property through May 24, 2033;

The Agreement is hereby modified as follows:

A. The Arizona Game and Fish Department shall:

1. Provide additional funding to the Landowner in the amount of forty-five thousand dollars (\$45,000.00) for public recreational access through or across the Subject Property. This additional funding will bring the total amount of the Agreement to \$65,000.00. Payment shall be made in one installment of \$45,000.00 and provided upon signature by both Parties to this Modification.

B. The Cooperator Shall:

 Allow public recreational access through or across the Subject Property through May 24, 2033.

C. The Department and Cooperator mutually agree:
