Dear Mr. Larsen,

Thanks for the voicemail last Thursday in response to the two recent Public Record Requests I submitted via email on May 18 for information about the expenditures from the Heritage Fund that were used to complete Public Access and Stewardship agreements with Arizona ranches. (The Stewardship agreements were sometimes referred to as Habitat Agreements in the fund's annual reports.) Those requests were assigned PRR #21-61 and #21-62 by Mr. Komadina.

During our subsequent phone conversation Friday morning you pointed out that a Public Record Request is just that, a request for an existing agency record, and you explained how my two requests asked for records that don't exist. As you know, I asked for spreadsheet type listings of the Public Access and Stewardship agreements that your agency has made with ranches. But you explained that your agency doesn't keep the ranch agreement records in that manner. There is no comprehensive or annual list of them, you said, only an individual project record for each agreement.

Subsequently, I am modifying my public record request #21-62 to ask for specific Stewardship agreement records that used Heritage Fund money, as defined in ARS § 17-298.A.2, which is the fund's sensitive wildlife habitat Identification, Inventory, Acquisition, Protection and Management (IIAPM) expenditure category. The IIAPM subcategory of Stewardship agreement expenditures first appeared in the fund's FY 1998 report, and then disappeared in the FY 2018 report.

So, using the Heritage Fund's annual reports as my primary reference, I now ask that you please provide copies of the records of the Stewardship/Habitat agreements that were made with the ranches listed below:

As can see, the examples of specific Stewardship agreements in the fund's annual reports began to diminish in the FY 2013 report, until they disappeared completely in the FY 2018 report, even though IIAPM funds have continued to be used for this purpose. So, if you discover additional agreements for the ranches listed above while you are obtaining copies of the ones I've requested, please provide copies of those too.

I assume these Stewardship/Habitat agreement records will include the year, recipient name, the Heritage Fund dollar amount, and form of compensation. Summary pages will suffice, as long as they include those primary details - especially the amount of money spent for each agreement.

As before, I will not use the information for commercial purposes.
