

**MODIFICATION NO. 1**  
**to**  
**COOPERATIVE STEWARDSHIP AGREEMENT**  
**FOR RECREATIONAL ACCESS**  
**Between**  
**THE ARIZONA GAME AND FISH COMMISSION**  
**and**  
**O'HACO CATTLE COMPANY,**  
**JIM O'HACO, LANDOWNER**

The purpose of this Modification is to increase funding and add five (5) additional years of Recreational Access to the Cooperative Stewardship Agreement with O'Haco Cattle Company (now Jim O'Haco Cattle Company), Jim O'Haco, Landowner.

**WHEREAS**, The Arizona Game and Fish Department ("Department"), under the authority of the Arizona Game and Fish Commission, and the Jim O'Haco Cattle Company, represented by Jim O'Haco ("Landowner"), entered into a Cooperative Stewardship Agreement for Recreational Access ("Agreement"), dated May 30, 2014, for the purpose of providing public recreational access through, upon, or across lands owned or legally controlled by the Landowner ("Subject Property") as illustrated on Exhibit A;

**WHEREAS**, The Department and the Landowner desire to continue to share in this mutually beneficial stewardship agreement;

**THEREFORE**, The Parties agree to modify the Agreement to provide additional funding to the Landowner and for the Landowner to allow public recreational access through, upon, or across Subject Property in areas as illustrated on Exhibit A for an additional five (5) years, ensuring public recreational access until May 30, 2024;

The Agreement is hereby modified as follows:

**A. The Arizona Game and Fish Department shall:**

1. Provide additional funding to the Landowner in the amount of seventy-five thousand dollars (\$75,000.00) for public recreational access on the Subject Property as illustrated on Exhibit A. This additional funding will bring the total amount of the Agreement to \$125,000.00.
2. Payment shall be made in one installment of \$75,000.00 and provided upon signature by both Parties to this Modification.

**B. The Landowner Shall:**

1. Allow public recreational access to the Subject Property as illustrated on Exhibit A for an additional five (5) year term bringing the Agreement end date to May 30, 2024. These additional years bring the total term of the agreement to ten (10) years.
