The following are your 2022 annual operating instructions (AOI) for your allotment.

<u>Authorized Use</u> You are authorized 24 adult cattle and 2 bulls from 3/1/2022 to 2/28/2023. Please fill out a *Modification of AOI* form in advance of the proposed dates and request approval. Please maintain and submit records that indicate your compliance to permitted use.

\*Lower and Upper Pastures are tentative due to the Telegraph Fire Burn Scar. Pastures will be inspected for ecological recovery and range readiness.

**<u>Range Improvement Maintenance</u>**: All range improvements must be maintained to Forest Service standards, available at District Office or in your AMP, as stated in your term grazing permit. Stock Tank cleaning is authorized provided there is a forest service road or motorized vehicle trail to said stock tank, and only until fire restrictions begin. You must contact Ryan Summers or Jamie Wages 1 week prior to cleaning each tank to receive final clearance. Absolutely no exemptions will occur once fire restrictions begin.

## Salting, Supplements, and Attractants:

In most cases, salt must be located no closer than <sup>1</sup>/<sub>4</sub> mile from streams, rivers, riparian areas, trails, and known archaeological sites. Protein blocks, nutritional supplement, and other attractant may be authorized prior to use. No supplemental feeding is authorized, such as hay.

The following is an update to your February 2022 Annual Operating Instructions (AOI). You recently requested to graze Lower pasture from April to end of October. This pasture had been moderately to severely impacted during the Telegraph Fire. An ecological inspection was conducted on March 2, 2022, to ascertain current pasture recovery conditions.


The only changes to your February 2022 AOI is the update below; the remaining stipulations are valid.

Lower	4/1/2022 to 10/31/2022	3/15/2022 7/15/2022	Cattle are not to be watered off private land. They must be kept west of private land in areas of the attached map.
Upper*	11/1/2022 to 2/28/2023 Tentative based on recovery inspections.	10/15/202 (Inspect recovery) 2/1/2023	

\*Upper Pastures are tentative due to the Telegraph Fire Burn Scar. Pasture will be inspected for ecological recovery and range readiness. A further letter will consider authorization of this pasture once an assessment is complete.

The area east of Pinto Creek, and particularly around FR349 will need more recovery time to be used. You may request a re-evaluation during the 2022 Monsoon season. The first sighting of cattle in this restricted area will require you to gather cattle within 72 hours. The second sighting of cattle in this area will result in a written warning and the third sighting will require you to remove cattle from Lower Pasture.
