11. DESCRIPTION OF MODIFICATION:

This modification incorporates Attachment D, Allotment Management Plan for the Roosevelt Allotment into the agreement; adds fiscal year 1993 funding in the amount of \$24,640 for the Plan; and specifies the estimated cost in the amount of \$36,960 for construction of the Roosevelt Allotment. Total funding for this agreement is hereby increased from \$132,700 to 157,340.

Except as provided herein, all terms and conditions of the document referenced in Block 9, as heretofore changed, remain unchanged and in full force and effect.
