It is bounded on the east by the deeded land and the Long H Allotment, deeded land to the south and the Navajo Reservation to the north and west. The general location is Township 18 North Range 27 East. The area is covered by the Hogan Well USGS Quadrangle, Arizona (7.5), and is shown in Figure 1.

Description of Proposed Action: Transfer the Puerco Ridge Allotment from Broken L Badlands to Lance and Kristen Knight. The authorized use will remain the same. Permits are for ten years.

This proposed action qualifies as a categorical exclusion under the Environmental Policy Act in accordance with 516 DM 11, 11.9, D (1): Rangeland Management-Approval of transfers of grazing preference. DOI-BLM-AZ-G010-2015-0011 Puerco Ridge Allotment Transfer.

This categorical exclusion is appropriate in this situation because there are no extraordinary circumstances potentially having effects that may significantly affect the environment. It has been reviewed to determine if any of the exceptions described in 516 DM 2, Appendix 2, apply.

The action does not have significant adverse effects on public health and safety nor does the action adversely affect such unique geographic characteristics as historic or cultural resources, parks, recreation, or refuge lands, wilderness areas, wild or scenic rivers, sole or principal drinking water aquifers, prime farmlands, wetlands, floodplains, or ecologically significant or critical areas, including those listed on the Department's National Register of Natural Landmarks.
