FLOOR AMENDMENT EXPLANATION

- **Prohibits members of the Livestock Loss Board from receiving monies from the Livestock Compensation Fund while serving on the Board.**

SENATE AMENDMENTS TO S.B. 1002

1 Page 1, between lines 1 and 2, insert:

2 "Section 1. Section 17-491, Arizona Revised Statutes, is amended to
3 read:

4 17-491. Livestock loss board; members; terms; compensation;
5 annual report

6 A. The livestock loss board is established to address the
7 depredation of wolves on livestock operations. The livestock loss board
8 consists of the following members:

9 1. The director of the Arizona department of agriculture or the
10 director's designee.

11 2. The director of the Arizona game and fish department or the
12 director's designee.

13 3. Three members who represent the livestock industry, who have
14 knowledge and experience with wildlife impacts and management and who are
15 appointed by the governor pursuant to section 38-211.

16 4. Two members who represent wildlife conservation or wildlife
17 management, who have knowledge and experience with livestock production or
18 management and who are appointed by the governor pursuant to section
19 38-211.

1 5. One member who is a livestock auction market owner and who is
2 appointed by the speaker of the house of representatives.

3 6. One member who is a faculty member at a university under the
4 jurisdiction of the Arizona board of regents, who has expertise in
5 agricultural and life sciences and who is appointed by the president of the
6 senate.

7 B. The initial members of the livestock loss board who are appointed
8 pursuant to subsection A, paragraphs 3, 4, 5 and 6 of this section shall
9 assign themselves by lot to terms of two and four years in office. All
10 subsequent members serve four-year terms of office. The chairperson shall
11 notify the governor's office, the president of the senate and the speaker
12 of the house of representatives of these appointments.

13 C. A majority of the members ~~constitute~~ CONSTITUTES a quorum.

14 D. The livestock loss board shall annually elect a chairperson from
15 its members.

16 E. Members of the livestock loss board are not eligible to receive
17 compensation but are eligible for reimbursement of expenses pursuant to
18 title 38, chapter 4, article 2.

19 F. MEMBERS OF THE LIVESTOCK LOSS BOARD MAY NOT RECEIVE MONIES FROM
20 THE LIVESTOCK COMPENSATION FUND FOR WOLF DEPREDATION ON LIVESTOCK OR
21 AVOIDANCE MEASURES PURSUANT TO THIS ARTICLE WHILE SERVING ON THE LIVESTOCK
22 LOSS BOARD.

1 ~~F.~~ G. The livestock loss board shall submit to the governor, the
2 president of the senate and the speaker of the house of representatives on
3 or before December 31 of each year a report of the number of applications
4 for compensation, the total amount of monies provided to landowners,
5 lessees and livestock operators that year and any recommendations. The
6 livestock loss board shall provide a copy of this report to the secretary
7 of state."
