This proposed action qualifies as a categorical exclusion under the National Environmental Policy Act in accordance with 516 DM 11, 11.9, D (1): Approval of transfers of grazing preference. And

In accordance with 43 CFR 46.215, this categorical exclusion is appropriate for the proposed action because no extraordinary circumstances apply:

The action would not have significant adverse effects on public health and safety nor would the action adversely affect such unique geographic characteristics as historic or cultural resources, parks, recreation, or refuge lands, wilderness areas, wild or scenic rivers, sole or principal drinking water aquifers, prime farmlands, wetlands, floodplains, or ecologically significant or critical areas, including those listed on the Department's National Register of Natural Landmarks. The action does not have highly controversial environmental effects nor have highly uncertain environmental effects, or involve unique or unknown environmental risk nor does it adversely affect a species listed or proposed to be listed on the list of endangered or threatened species. It would not establish a precedent for future action nor represent a decision in principle about a future consideration with significant environmental effects. The proposed action would not adversely affect properties listed or eligible for listing in the National Register of Historic Places. The action would not threaten to violate a Federal, State, local or tribal law or requirements imposed for the protection of the environment or which require compliance with Executive Order 11988 (Floodplain Management), Executive Order 11990 (Protection of Wetlands) or the Fish and Wildlife Coordination Act.
