You are authorized 37 bulls yearlong and 18 horses yearlong. You are authorized 265 adult cattle 3/1/2024-5/31/2024 increasing to 345 on 6/1/2024 and decreasing to 315 from 10/1/2024 to 2/29/2025. You are also authorized 215 yearlings 3/1/2024-5/31/2024.

Range Improvement Maintenance: All range improvements must be maintained to Forest Service standards (available at District Office) before cattle will be allowed to enter pastures. Stock Tank cleaning is authorized provided there is a forest service road or motorized vehicle trail to said stock tank, and only until fire restrictions begin. You must contact Ryan Summers one week prior to cleaning each tank to receive final clearance. Range improvements must be maintained to Forest Service standards (available at District Office) before cattle will be allowed to enter pastures.
