

Annual Operating Instructions

NUTRIOSO SUMMER ALLOTMENT AND WEST FORK ALLOTMENT

Alpine Ranger District
Apache-Sitgreaves National Forests

2023 grazing season

1. PASTURE USE SCHEDULE

I have approved your application to graze up to 113 head of cattle on the West Fork Allotment and up to 91 head of cattle on the Nutrioso Summer Allotment. The following tables outline the grazing rotation:

The schedule & level of authorized use above is an estimate and may be modified at any time prior to or during the grazing season if utilization levels, identified below, are met, if water availability is inadequate, or for other resource management reasons.

2. UTILIZATION STANDARDS

The following utilization standards will be applied on both the Nutrioso Summer and West Fork Allotments:

- 25% use, by weight of current year's growth, on upland perennial grass species.
- 25% use, by weight of current year's growth, on riparian grass species.

3. KEY AREA MONITORING

Livestock grazing utilization monitoring may be conducted in key areas near the midpoint or end of the grazing period, or at the end of the growing season for each pasture. It is a permittees responsibility to act so that livestock grazing does not exceed the allowable use guidelines. Proper salt placement (more than a ¼ mile from water, and away from roads), hauling water, and herding or riding are recommended. If the problem cannot be corrected with preventative measures, then early exits from the pastures, adjustments in the AMP, stocking levels, or other management or administrative actions may be necessary.

The purpose of utilization monitoring is to ensure that herbaceous vegetation is managed to provide for suitable habitat and forage for various wildlife species, to meet physiological requirements for forage and browse plants, and promote or maintain proper range/watershed conditions.

District personnel may contact the permittees to coordinate site visits to monitor key areas, when practical. Permittee participation is encouraged. Forage utilization estimates will be consistent with the Forest Service Range Analysis Handbook methodology and may also include FS Regional stubble-height standards, as well as other techniques generally accepted in the field of range management.

4. RANGE IMPROVEMENTS

Maintenance of range improvements: Permittees will maintain assigned range improvements within their Allotment. This is in accordance with Part 3, clause 2 of the term grazing permit. If your neighbor is turning out before you on an adjacent pasture and the boundary fence is your responsibility, this fence must be repaired before your neighbor turns out. Routine maintenance of existing improvements does not require written clearance; however, construction or reconstruction of improvements must be authorized in writing from this office.

5. SPECIAL MANAGEMENT INSTRUCTIONS

Camping: As the Term Grazing Permit holder this AOI authorizes [REDACTED] and those employed by them to exceed the 14-day camping stay limit to adequately maintain the range improvements associated with the Nutrioso Summer and West Fork allotments.

- [REDACTED] and his employees will be camped at the Greenhead Trap Corral located off the 88B road (sec. 35 NE 1/4) from 6/15 – 10/31, to accomplish the grazing management activities. **This section must be visible to Forest patrols.**

- [REDACTED] and his employees will be camped at the Antelope Prairie Corral located off the 25G road (sec. 16 NE ¼) from 6/15 – 11/15, to accomplish the grazing management activities. **This section must be visible to Forest patrols.**

Livestock Distribution: Salting and maintaining improvements are good ways to achieve proper livestock distribution. Frequent riding may be necessary to break up concentrations of livestock. A full-time rider may be needed to herd livestock onto lightly used areas, reducing grazing pressure on riparian areas and meadows.

Fire Prevention: All vehicles should be equipped with a properly functioning exhaust system. A shovel and axe for use in extinguishing camp and forest fires should be carried. All open camp and branding fires, when allowed, must have a fire ring down to the mineral soil, and be handled in a safe manner.
