- On June 25, 2002, the State Land Commissioner issued Order No. 349-2001/2002, a Notice of Conflicting Applications for Lease, to conflicting applicant John Horning on behalf of Forest Guardians (Forest Guardians), Application No. 05-103431, and the current lessee, Cataract Natural Reserve Land (Cataract Reserve), Lease No. 05-216. This order called for submission of Statements of Equity by each party to the Department.
- Both the applicant, Forest Guardians, and the lessee, Cataract Reserve, submitted their Statements of Equity to the Department on July 25, 2002.
- On August 5, 2002, the conflicting applicant, Forest Guardians, submitted a Notice of Withdrawal for Application No. 05-103431, based upon their willingness to reimburse the lessee for improvements listed in Cataract's Statement of Equity.
